#### 1. Personal Data Collected

We may collect and process Personal Data including, but not limited to:

- Government-issued identification numbers (PAN, Aadhaar, GSTIN, etc.)
- Bank account details

- Documents submitted as part of KYC, Vendor/Supplier Evaluation, onboarding, and contracting processes

#### 2. Purpose of Processing

Your Personal Data may be processed for:

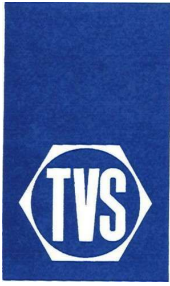
- Assessing your eligibility and suitability as a Service Provider / Supplier / Vendor

#### 4. Your Rights

- Withdraw consent (subject to contractual or legal requirements)
- File a grievance with SFL

Personal Data will be retained only for as long as necessary to fulfil the purposes stated above or as required by law. Thereafter, it will be securely deleted or anonymized in accordance with SFL's internal policies.
