Sub: Scrutinizer's Report on 13th Postal ballot conducted under Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 of Companies (Management and Administration) Rules, 2014 from 8th August 2022 to 6th September 2022

The Board of Directors of your Company have, vide a resolution passed on **29th July 2022**, decided to conduct the 13th Postal Ballot from 8th August 2022 to 6th September 2022 through remote e-voting, without sending physical ballots, as permitted by the Ministry of Corporate Affairs **(MCA)** and the Securities and Exchange Board of India **(SEBI)** through their circulars, to obtain the approval of your members by way of **ordinary resolution** for the following **item** of business:

Business being transacted through the 13th Postal Ballot through Ordinary Resolution

Approval of the request received from T V Sundram Iyengar & Sons Private Limited for re-classification of their status as well as the status of Southern Roadways Private Limited from 'Promoter' category to 'Public' category in terms of Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

I have been appointed to act as the Scrutiniser for the 13th Postal Ballot process.

I submit my report as under:

- 1. Sundram Fasteners Limited ("the Company") is a listed company with its equity shares being listed with the National Stock Exchange of India Limited (NSE) and the BSE Limited (BSE)
- 2. The Company selected National Securities Depository Limited (**NSDL**), as the agency to provide the e-voting platform for the remote e-voting process. NSDL allotted E-voting Event Number (EVEN) 120677 for the Company's 13th Postal Ballot.
- The Company fixed 29th July 2022 as the cut-off date for determining the members who would be eligible to vote through the remote e-voting process and the number of votes each of them could exercise.
- 4. Notice of the 13th Postal Ballot was sent on 8th August 2022, to:
 - (a) 63,596 members through email by NSDL whose email address were registered with the Company/Depositors and 3 members (with invalid e-mail address) through Courier (Physical copy) by the Company, out of the total of 68,522 members as on 29th July, 2022.

- (b) Through e-mail to the **Directors, Auditors, Secretarial Auditors and Cost Auditor** of the Company.
- The Company has also placed the Notice of the Postal Ballot on its website and filed it with the NSE and BSE in terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (LODR) on 8th August 2022.
- The Company has duly advertised the Notice and other prescribed particulars about the remote e-voting process on 9th August 2022 in Business Standard (in English) and Makkal Kural (in Tamil).
- 7. Integrated Registry Management Services Private Limited, the Company's Registrar and Share Transfer Agents (**RTA**), provided the details of the members who held shares on the cut-off date and the number of shares held by each of them on that date.
- 8. The Company's paid-up equity share capital **as on the cut-off date**, which consisted of 21,01,28,370 equity shares of Re.1/- each held by **68,522 members**, included equity shares on which **voting rights were frozen**, as set out below:
 - (a) **7,20,473** equity shares in Sundram Fasteners Limited Unclaimed Suspense Account, in terms of Regulation 39 read with Schedule VI of LODR; and
 - (b) **10,89,090** equity shares on which dividend had not been claimed for seven consecutive years and transferred to and held by the Investor Education and Protection Fund Authority Ministry Of Corporate Affairs (**IEPF**) as per Section 124(6) of the Act.

Hence, 68,520 members holding an aggregate 20,83,18,807 equity shares were entitled to vote in the 13th Postal Ballot.

- 9. The Company fixed the remote e-voting period to start from 9.00 am on Monday the 8th August 2022 and end at 5.00 pm on Tuesday the 6th September 2022.
- 10. After 5.00 P.M. on Tuesday, the 6th September 2022, I unblocked the votes cast through remote e-voting in the presence of two witnesses not in the employment of the Company and obtained the remote e-voting report from the e-voting website of NSDL.
- 11. The votes cast through remote e-voting have been validated with the list of members and their holding as on the cut-off date.
- 12. I also noted that voting rights were not exercised in respect of the **7,20,473** equity shares in Sundram Fasteners Limited Unclaimed Suspense Account as well as the **10,89,090** equity shares held by IEPF.
- 13. **851 members participated** in the 13th Postal Ballot and cast **votes** through the remote e-voting process, all of which were considered as valid.
- 14. I have recorded particulars of the votes cast through remote e-voting in a separate register maintained in electronic form.
