Sub: Scrutinizer's Report on 5th Postal ballot conducted under Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 of Companies (Management and Administration) Rules, 2014

I have, vide a resolution passed by your Board of Directors on 22nd November, 2017, been **appointed to act as the Scrutiniser** for the Company's **fifth postal ballot** process, which was initiated to obtain the approval of your members for **three** items of business as set out below:

I submit my report as under:

- 1. The Company is a listed company with the equity shares being listed with the National Stock Exchange of India Limited (NSE) and the BSE Limited (BSE).
- The Company selected National Securities Depository Limited (NSDL), as the agency to provide
 the e-voting platform for the remote e-voting process. NSDL allotted E-voting Event Number
 (EVEN) 108045 for the Company's 5th Postal Ballot.
- 24th November 2017 was fixed by your Board as the cut-off date for determining the
 members who were eligible to vote either through remote e-voting or through physical ballot
 and the number of votes each of them could exercise.
- 4. The voting period was from 9.00 am on 4th December 2017 to 5.00 pm on 2nd January 2018.

- Integrated Registry Management Services Private Limited, your Share Transfer Agents (RTA), provided the details of the members who held shares on the cut-off date and accordingly were eligible to participate in the postal ballot.
- 6. The Company's paid-up equity share capital as on the cut-off date consisted of 21,01,28,370 equity shares of Rs. 1/- each, which was held by 54,961 members. This included 17,17,532 equity shares lying in Sundram Fasteners Limited Unclaimed Suspense Account on which voting rights were frozen in terms of Regulation 39 read with Schedule VI of LODR.
- 7. On 4th December 2017, notice of the 5th Postal Ballot was:
 - (a) Sent to the eligible members as set out below:
 - (i). Through registered post [sent by RTA] to 15,100 members, along with ballot paper and postage prepaid business reply envelope.
 - (ii). Through e-mail (sent by NSDL) to 39,861 members.
 - (b) Filed online with the NSE and BSE in terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosures) Regulations, 2015 (LODR).
 - (c) Sent by email to all the directors and the statutory, secretarial and cost auditors of the Company.
- The Notice and prescribed particulars about the remote e-voting process were duly advertised
 on 5th December 2017 in The Economic Times (in English) and Makkal Kural (in Tamil) and
 also placed in the Company's website.
- 9. All the physical postal ballots received in the postage pre-paid business reply envelopes upto 5.00 pm on 2nd January 2018 were opened in my presence and scrutinised. I did not receive any physical postal ballot forms after that date and time.
- 10. **After 5.00 P.M. on 2**nd **January 2018**, I also unblocked the votes cast through **remote e-voting** in the presence of two witnesses not in the employment of the Company and generated the remote e-voting report from the e-voting website of NSDL.
- 11. I have **scrutinized the votes cast** through remote e-voting as well as through physical postal ballots and validated the same with the list of members and their holding as on the cut-off date.
- 12. I have also verified and confirmed that no voting rights were exercised in respect of any of the 17,17,532 equity shares lying in Sundram Fasteners Limited Unclaimed Suspense Account in terms of LODR.
- 13. I have recorded particulars of the votes cast through remote e-voting and the physical ballots in a separate register maintained in electronic form.
- 14. The participation of members in the voting was as follows:
 - (a) Number of Postal ballots received-

- 15. All the electronic ballots were considered as valid since they were cast in a secure platform. Some of the physical ballots were treated as invalid for various reasons. In view of the ballots themselves being considered as invalid, quantifying the number of invalid votes did not arise.
