The Hon'ble National Company Law Tribunal, Chennai bench, vide its order dated December 6, 2021 had approved the composite scheme of amalgamation and arrangement (demerger) inter alia amongst T V Sundram Industries Private Limited ("TVSS"), Sundram Industries Private Limited ("SPL") ("Composite Scheme") in accordance with Sections 230 to 232 and other applicable provisions under the Companies Act, 2013 read with the rules made thereunder and other applicable laws. The Composite Scheme was made effective on January 6, 2022 ("Effective Date"). As per the Composite Scheme, on the Effective Date, SIPL and SRPL were amalgamated with TVSS and have been dissolved without the process of winding up. As a result of this, the shareholding of SRPL in Sundram Fasteners Limited (SFL) was vested in / transferred to TVSS. As a subsequent step to the above, in terms of the Composite Scheme, on February 4, 2022, TVSS demerged a business undertaking which included shareholding held in the Company to TPL. Consequent to the above, TPL has become the Promoter of SFL.

The Company had submitted an application with the Stock Exchanges for reclassifying TVSS from "Promoter" category to "Public" category dated September 29, 2022. Pursuant to the same, the Stock Exchanges vide their letter dated January 3, 2025, has accorded approval for reclassifying TV Sundram Iyengar & Sons Private Limited from "Promoter" category to "Public" category. The effect of the same will be provided in the shareholding pattern from ensuing quarters.
